RESOLUTION 91-9

RESOLUTION OF THE BOARD OF DIRECTORS OF THE RANCHO MURIETA COMMUNITY SERVICES DISTRICT REGARDING WATER CONSERVATION

WHEREAS, California is now experiencing the fifth consecutive critically dry year; and,

WHEREAS, the annual yield of the Cosumnes River is approximately 28 per cent of normal; and,

WHEREAS, the District is currently experiencing a 200 year drought; and,

WHEREAS, the conservation of the District's existing water supply is vital to health and safety of District customers.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of Rancho Murieta Community Services District hereby adopts the following voluntary water conservation program:

- 1. Irrigation between noon and 6:00 p.m. will be discouraged.
- 2. Odd/even irrigation scheduling will be encouraged. The last digit in a customer's address will determine which days that customer will be allowed to irrigate. Even digits may irrigate on Tuesdays, Thursdays, and/or Saturdays. Odd digits may irrigate on Wednesdays, Fridays, and/or Sundays. Irrigation on Mondays will be discouraged.
- 3. Irrigation water permitted to run off property for any reason will be discouraged. Gutter flooding or similar waste of water will be discouraged.
- 4. Washing of paved surfaces will be discouraged except as required for public health and safety purposes.
- 5. Washing of motor vehicles, mobile homes, trailers, boats, golf carts, etc. will be discouraged except by water contained in a bucket and a hose equipped with an automatic shut-off nozzle.
- 6. Washing down of buildings or use of water for cooling of roofs will be discouraged.
- 7. Failure to repair a controllable leak of water will be a violation of Section 10 of the District Water Code.
- 8. Water efficient landscaping will be encouraged.
- 9. Open flows to ornamental ponds or lakes, or the use of fountains will be discouraged, except as required for public health, safety or water quality reasons.
- 10. The use of indoor water conservation is encouraged.
- 11. The use of water conservation devices in new construction will be encouraged.

- 12. The use of domestic water supplies for dust control in construction will be discouraged.
- 13. The unreasonable use and the waste of water will be discouraged.
- 14. The "dump and fill" practice of pool maintenance will be discouraged.
- 15. The service of water by any restaurant, except upon the request of the patron, will be discouraged.
- 16. The use of water to fill any privately owned water tanks will be discouraged.
- 17. The use of free flowing hoses will be discouraged.
- 18. The use of fire hydrants for non-essential needs will be discouraged.
- 19. Nothing in this Conservation Plan shall limit or restrict any public agency engaged in providing emergency services from making any use whatsoever of the public water supply for purposes associated with the provision of emergency services.
- 20. Nothing in this Conservation Plan shall limit or restrict the Water System itself from using water in any manner or fashion necessary for maintaining the public water supply.
- 21. The District Manager shall enforce this water conservation program pursuant to Section 10 of the District Water Code.

THIS RESOLUTION is hereby declared to be effective for the period March 1, 1991, and ending December 31, 1991. The District Board may extend the effective period of this resolution or make changes in the Water Conservation Program as deemed appropriate, from time to time.
