## FIX A LEAK WEEK ~ March 19 - 25, 2018

Are you ready to chase down leaks? Household leaks can waste more than a trillion gallons of water annually nationwide, so each year we hunt down the drips during Fix a Leak Week. Mark your calendars for EPA's annual Fix a Leak Week, March 19 through 25, 2018; but remember that you can find and fix leaks inside and outside your home to save valuable water and money all year long.

To check for leaks in your home, you first need to determine whether you are wasting water and then identify the source of the leak. Here are some tips for finding leaks:

- Take a look at your water usage during a colder month, such as January or February. If a family of four (4) exceeds 12,000 gallons per month, there are serious leaks.
- Check your water meter before and after a two-hour period when no water is being used. If the meter changes at all, you probably have a leak.
- Identify toilet leaks by placing a drop of food coloring in the toilet tank. If any color shows up in the bowl after 10 minutes, you have a leak. (Be sure to flush immediately after the experiment to avoid staining the tank.)
- Examine faucet gaskets and pipe fittings for any water on the outside of the pipe to check for surface leaks.
- The vast majority of leaks can be eliminated by retrofitting a household with new WaterSense labeled fixtures and other high-efficiency appliances.

The Rancho Murieta Community Services District's (District) Security Department suggests that all individuals and businesses take the time to visit the **CodeRED** website and update and/or add contact information to include cellular phones and other non-traditional phones as well as email and text addresses. If your contact information is not in the database you will not receive a call when an urgent message is sent. In particular, businesses should register, as well as individuals who have unlisted phone numbers, people who have changed their phone number recently, and those who use a cellular phone exclusively or have VoIP phones (such as Vonage) as their primary numbers.
