RECOMMENDED ACTION

Appoint District Director ______ as District Representative on the Sacramento County Stakeholders Committee Regarding Development in Rancho Murieta.

BACKGROUND

Sacramento County Supervisor Roberta MacGlashan contacted the District regarding the County's request to hold "Stakeholder Meetings" regarding development in Rancho Murieta and asked that the District appoint one of their Directors, along with the General Manager, to represent the District at these meetings. The meetings will be day-time meetings and the first meeting is tentatively scheduled for June 3, 2016. Stakeholder groups include local Ranchers, the District, the Applicant (Developer), SOLOS, and Rancho Murieta Association (RMA). Supervisor MacGlashan anticipates as many as six (6) meetings with each meeting covering a different topic of discussion such as Transportation/Traffic; Sewer and Water; Open Space and Trails, Land Use and Density, etc.

Subject: Consider Adoption of Resolution 2016-06 a Resolution Repealing Stage Two Water

Shortage Conditions and Revising Water Use Restrictions

RECOMMENDED ACTION

Adopt Resolution 2016-06 a Resolution Repealing Stage Two Water Shortage Conditions and Revising Water Use Restrictions.

BACKGROUND

On May 9, 2016, Governor Brown issued an Executive Order confirming that drought conditions persist in many parts of the state and directing actions aimed at reducing water waste and improving water use efficiency in the future. The order also directs the State Water Resources Control Board (SWRCB) to extend its emergency water conservation regulations through the end of January 2017 and to adjust the regulations to recognize the differing water supply conditions across the state.

On May 18, 2016, the State Board amended its emergency water conservation regulations as directed by the Governor. The regulations remain subject to final approval by the State Office of Administrative Law. That approval is expected in late May or early June.

The state has lifted the mandatory water conservation requirement. As applied to a non-urban water supplier like Rancho Murieta Community Services District (District), the amended regulations now require the District to take the following actions: (1) provide prompt notice to a customer whenever the District obtains information that indicates that a leak may exist within the customer's control; and (2) submit a report by December 15, 2016, on a form provided by the State Board, that identifies (i) total potable water production, by month, from December 2015 through November 2016, and total potable water production, by month, for the same months in 2013, and (ii) any actions taken by the District to encourage or require its customers to conserve water. (Sec. 865(g).)

Staff recommends that the District move to a Stage One – Water Alert based on the health of the District water supply and projections that the water supply can reliably serve the community over the next three (3) years if drought conditions persist in the State. Stage One allows outside irrigation three days per week (see the attached for the irrigation schedule) and asks for a voluntary conservation of 10% from normal conditions. 2013 has been identified by the SWRCB as the basis of conservation savings and as such the District will use the same basis for calculating the Stage One conservation compliance by the community. District staff will continue to monitor the

health of the District's water supply and will make future recommendations regarding drought declaration, as needed, to ensure a reliable water supply to the community.		

RESOLUTION NO. R2016-06

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE RANCHO MURIETA COMMUNITY SERVICES DISTRICT REPEALING STAGE TWO WATER SHORTAGE CONDITION AND REVISING WATER USE RESTRICTIONS

BE IT RESOLVED by the Board of Directors of the Rancho Murieta Community Services District as follows:

- 1. **Recitals**. This resolution is made with reference to the following background recitals:
 - (a) California and the Sacramento Valley experienced a serious multi-year drought. Consequently, on April 1, 2015, the Governor issued an Executive Order directing the State Water Resources Control Board ("SWRCB") to impose mandatory water usage restrictions to achieve a statewide twenty-five percent (25%) reduction in potable urban water usage through February 28, 2016. On May 9, 2016, the Governor issued a new Executive Order that continues in effect the April 1, 2015 and related orders and directs the SWRCB to adjust its emergency water conservation regulations to continue in effect through January 2017 and to address the differing water supply conditions across the state. On May 18, 2016, the SWRCB amended its emergency water conservation regulations.
 - (b) The District's Water Shortage Contingency Plan sets forth the actions to be undertaken by the District during a water shortage. The plan groups water supply and conditions into five stages, with the "Normal Stage" used for normal water supply conditions and Stages 1 through 4 used for water shortage conditions of increasing severity.
 - (c) As of May 23, 2016, the District water supply reservoirs are filled to near capacity and, locally, the District is not experiencing any drought conditions and is not anticipating any water supply shortage.
 - (d) Amended California Code of Regulations, title 23, section 865(g) no longer requires public water supply distributors like the District to limit their customers' outdoor irrigation of ornamental landscapes or turf with potable water to no more than two (2) days per week, or to implement other water conservation measures to reduce total potable water production by 25% relative to the amount produced in 2013.
 - (e) In Resolution No. 2015-06, the District Board declared a Stage 2 water shortage condition and imposed water usage restrictions to comply with the SWRCB's emergency water conservation regulations, conserve the State's declining water supplies, and work towards achieving the water conservation goals set forth in the Governor's April 1, 2015 Executive Order.

- (f) In light of the favorable water supply conditions and the expected amendment of the SWRCB emergency water conservation regulations, the Board determines that the District no longer is in a Stage 2 water shortage condition and that it is appropriate to lift the Stage 2 condition.
- 2. **Authority**. This Resolution is adopted pursuant to Government Code section 61060, California Code of Regulations, title 23, section 865, District Code chapter 14 (Water Code), the District's Water Shortage Contingency Plan, and other applicable law.
- 3. Water Shortage Declaration Modified. The Board of Directors repeals the Stage 2 water supply condition determination and the related water use restrictions. The Board determines that a Stage 1 water supply condition (water alert) exists in the District.
- 4. Water Use Restrictions. The Board of Directors encourages voluntary measures to decrease normal demand up to 10%. The Board directs staff to implement and monitor the Normal and Stage 1 actions and limitations in the District Water Shortage Contingency Plan, which are attached hereto for reference. The Board directs staff to comply with and implement California Code of Regulations, title 23, section 865(g) (as amended). The Board directs that the District enforce the following ongoing state-mandated prohibitions against certain water uses as set forth in title 23, section 864(a) (as amended), except where necessary to address an immediate health and safety need or to comply with a state or federal agency permit:
 - (a) The application of potable water to outdoor landscapes in a manner that causes runoff such that water flows onto adjacent property, non-irrigated areas, private and public walkways, roadways, parking lots, or structures;
 - (b) The use of a hose that dispenses potable water to wash a motor vehicle, except where the hose is fitted with a shut-off nozzle or device attached to it that causes it to cease dispensing water immediately when not in use;
 - (c) The application of potable water to driveways and sidewalks;
 - (d) The use of potable water in a fountain or other decorative water feature, except where the water is part of a recirculating system;
 - (e) The application of potable water to outdoor landscapes during and within 48 hours after measurable rainfall;
 - (f) The serving of drinking water other than upon request in eating or drinking establishments, including but not limited to restaurants, hotels, cafes, cafeterias, bars, or other public places where food or drink are served and/or purchased;
 - (g) The irrigation with potable water of ornamental turf on public street medians; and,
 - (h) The irrigation with potable water of landscapes outside of newly constructed homes and buildings in a manner inconsistent with regulations or other requirements established by the California Building Standards Commission and the Department of Housing and Community Development.

- 5. **Enforcement**. The General Manager is authorized and directed to enforce the water use restrictions in this resolution. For an ongoing violation of this resolution after receipt of a notice to comply, the District may terminate water service to the premises where the violation occurs.
- 6. **Fire and Emergencies**. Nothing in this resolution shall apply to the use of water for purposes of extinguishing fires or responding to other emergency conditions.
- 7. **Effective Date**. This resolution shall take effect immediately upon its adoption and will remain in effect until repealed or amended by the Board of Directors.
- 8. Amendment. This resolution amends and supersedes Resolution No. 2015-06.

WATER SHORTAGE MEASURES STAGE DEFINITIONS

Stage One - Water Alert

Goal is 10% Reduction per Average Household or Business

- 1. All Stage "Normal" actions remain in force; unless revised herein.
- All customers are encouraged to report observed water waste. The District's Security Officers will be notifying District operations of any observed water waste for follow-up action.
- Prohibit washing of streets, parking lots, driveways, sidewalks, or buildings, except as
 necessary for health or sanitary purposes. High efficiency pressurized water brooms are
 required for these purposes, conventional pressure washers or hoses with shut-off
 nozzles are not allowed.
- 4. Landscape irrigation shall be watered efficiently, preferably with a weather based irrigation controller or hose timer. If a weather based controller is not installed, change the minutes of run-time for irrigation valves consistent with fluctuations in weather as determined by evapotranspiration data provided by the District/Regional Water Authority.
- 5. Watering is limited to a maximum of **three (3) days per week** if and when necessary and no watering schedule (e.g., additional minutes) increases are permissible on designated watering days. Three (3) days per week water is sufficient for landscapes in the Rancho Murieta Community. Customers are to use cycle and soak watering with up to three (3) short watering cycles. Watering days need to be based on the following schedule.
 - Customers in Watering Group A may irrigate only on Monday, Wednesday and Friday.
 - Customers in Watering Group B may irrigate only on Tuesday, Thursday and Saturday.
 - **♦** Sunday irrigation is not allowed.
- 6. Residents are encouraged to reduce indoor water use by limiting showers. Washing full clothes washer and dishwasher loads.
- 7. Restaurants shall serve water only upon specific request.

RANCHO MURIETA COMMUNITY SERVICES DISTRICT WATER CONSERVATION MEASURES

"Normal" Supply and On-going Conservation Requested of Every Household or Business

- 1. Water will be used for beneficial uses; all unnecessary and wasteful uses of water are prohibited as described in District Code Chapter 14 Water Code. Take advantage of the free information available from the District on how to use water efficiently, read a water meter, repair leaks, and irrigate efficiently. Up to date information is provided through the District's web site.
- 2. Use water efficiently. Water shall be confined to the consumer's property and shall not be allowed to run off to adjoining property or to the gutter. Care shall be taken not to water past the point of soil saturation. Customers are encouraged to report observed water waste. Two (2) to three (3) days per week using cycle and soak methods is sufficient for landscapes in the Rancho Murieta Community.
- 3. Prohibit free-flowing hoses for all uses including vehicle and equipment washing, ponds, and evaporative coolers. Use a hose and bucket method for washing and attach automatic shut-off devices on any hose or filling apparatus in use.
- 4. Regularly check and maintain irrigation systems, repair leaks, and adjust spray heads to provide optimum coverage and eliminate avoidable over-spray. Reduce minutes of run-time for each irrigation valve if water run-off (gutter flooding) is occurring.
- 5. Automatic sprinkler system timers shall be set to operate during cool evening hours and early morning hours when evaporation rates are low and on off-peak electrical hours (ideally between 3 a.m. and 6:00 a.m.). Customers are encouraged to reduce scheduled watering minutes.
- Repair all leaks promptly. Leaking consumer pipes or faulty sprinklers shall be repaired within seven (7) days or less if warranted by the severity of the problem and subject to penalties as described in District Code – Chapter 14, Water Code, Section 13.03.
- 7. Properly maintain all pools, spas, and ornamental fountains/ponds to avoid drain and refill. All water features and pools shall be equipped with a recirculating pump and shall be constructed to be leak-proof. Pool draining and refilling shall be allowed only for health, maintenance, or structural considerations. Customer requests must be substantiated in writing by a pool consultant and approved by the District.
- Avoid washing of streets, parking lots, driveways, sidewalks, or buildings, except as
 necessary for health or sanitary purposes. Use a high efficiency pressurized water
 broom for these purposes and not a conventional pressure washer or hose with a
 shut-off nozzle.

U.S. Environmental Protection Agency (EPA) WaterSense labeled water efficient plumbing fixtures, water efficient appliances, and high efficiency irrigation techniques, such as drip, are encouraged, as described in District Code – Chapter 14 – Water Code, Section 11 and found online at: www.epa.gov/watersense.
