OPERATIONS UPDATES

The Department is currently working on the following projects:

- Additional Valor Security staff to support Security Gate & Patrol until vacancies are filled
- Recruitment for the Security Supervisor: (see Agenda Item 5)
- Continuing Recruitment for Gate and Patrol Officers: one Gate Officer resigned; one Patrol Officer applicant in backgrounds
- County citations update: (see Agenda Item 6)
- Summer Events Planning/Extra staffing: SSD is on hire back on Fridays until further notice (eve hours); responds to District calls and provides patrol services; will utilize Valor Security as needed for extra patrol
- RFP for Contract Security Services: (see Agenda item 8)
- AEDs received – Policy being written for implementation of devices
- RMCC events: we are working with RMCC staff to set up a meeting to discuss upcoming events and how to alleviate traffic flow/backup at the gates

Rancho Murieta Association activity:

We continue to work with the RMA Leadership on a regular basis. Our focus is to improve our level of service and have positive contacts with residents. If there are incidents where there is a safety concern, they notify Security Dispatch to call the Sacramento Sheriff's Department. The following list is the current focus of our meetings.

- General non-architectural enforcement
- Stop Sign enforcement – enforcement missions conducted each week; other violations issued during regular patrol
- Speed enforcement –enforcement missions conducted each week during the daytime hours only; other violations issued during regular patrol
- License Plate Reader (LPR) cameras at North and South gates: Watchdog Security will be installing LPR cameras for the outbound/exit #2 lane/bike lane at the North gate beginning the week of May 17; Repair of South gate LPR: we are awaiting response from Watchdog Security for the electrical/power work that needs to be done.
- Barcode readers: we are getting new bar code readers; PO approved
- RMA Compliance Meetings

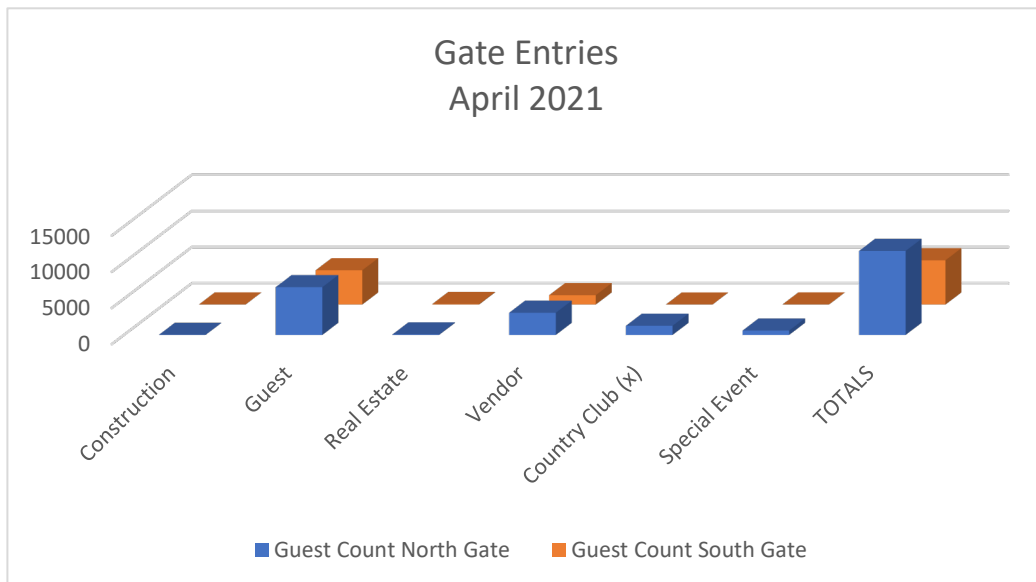

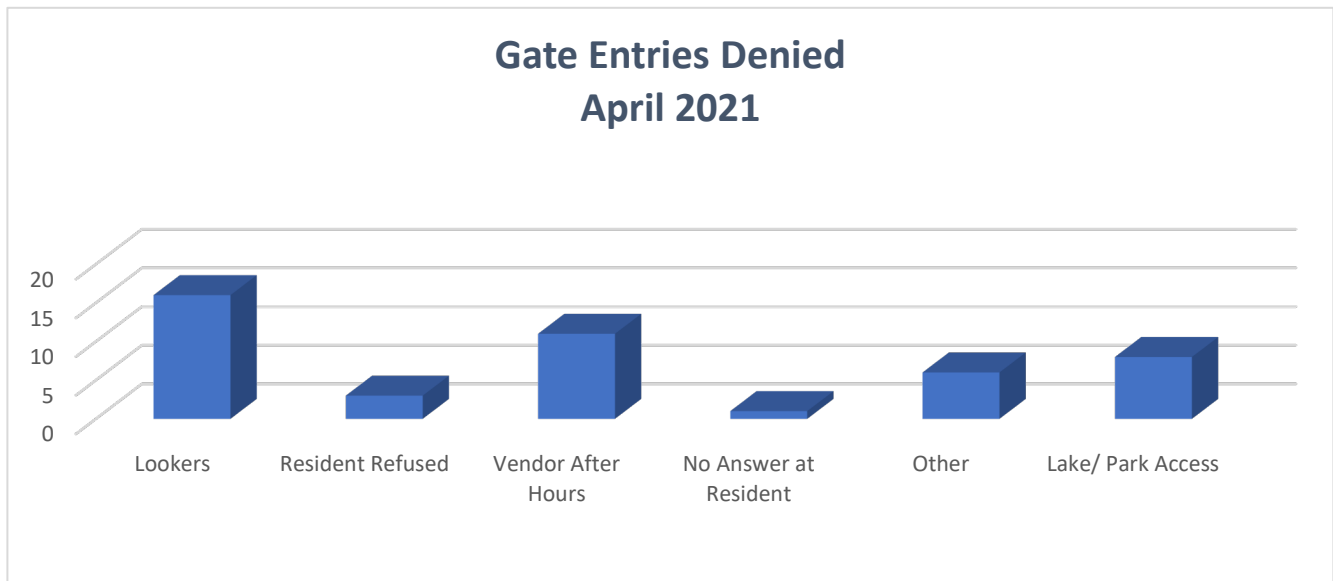

APRIL 1-30, 2021

April 4, 2021: Gunshots
