LEAF RAKING TIME

With summer ending, the leaves are changing colors and dropping from the trees. Raked leaves can fill the green waste container quickly. If you have more leaves and green waste than your container can handle, place the leaves in a plastic bag, securely fasten the bag, and place it alongside your gray container for regular pickup.

California Waste Recovery Systems (Cal Waste) provides this service annually from December 1st to March 31st, at no additional cost.

NOVEMBER IS F.O.G. – FATS, OILS AND GREASE - MONTH

FOG is not only a weather phenomenon, but in the sewer system it can be a real problem. This **F.O.G.** is **fats**, **oils**, and **grease**. With Thanksgiving around the corner, as a reminder, all cooking grease (frying oils, salad oils, bacon grease, meat drippings, and greasy leftovers) can create plumbing problems, particularly for our sewer collection system and treatment plant, if poured down sink drains. If small amounts of grease accidentally get into a drain, flush immediately with **COLD** water. Hot water and detergent only break up the grease temporarily.

Any cooking oil produced for food preparation and consumption purposes that are no longer useful because of use, extended storage, or spillage can be set out for collection. Just call Cal Waste at 916-354-4154 and they will deliver empty containers for your used cooking oil. Then set out the full containers on your next regular collection day. Used cooking oil shall not contain water, soapsuds, and/or food debris.

Likewise, be careful with putting excess foods in your garbage disposal as they can lead to clogs in the garbage disposal and sewer service.

NEW REBATE PROGRAM

The District is pleased to announce that our new rebate program for Irrigation Efficiencies is now available. The program offers a rebate of up to \$500 per residential account/meter and \$1,500 per commercial account/meter. The program requires an initial water use survey to be performed (free of charge to the applicant) which will identify recommended landscape upgrades to be implemented. The rebate is applicable only to installation of the recommended landscape upgrades, which may include upgrades such as replacing sprayers in non-turf areas with low volume drip irrigation systems, removing pop-up spray heads in turf areas and replacing them with low precipitation, high distribution uniformity or multi-stream nozzles with an inches per hour flow rate of 1.10, and turf removal. Applicants are required to comply with RMA's landscape review process when required for the recommended upgrade. RMA has agreed to waive their \$100 review fee for implementing drought tolerant landscaping. Check the District website in early November for the application form and information on the application process.

This program is financed under the Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006 (Proposition 84, Chapter 2), administered by State of California, Department of Water Resources. WATER TREATMENT PLANT EXPANSION PROJECT UPDATE

Recent work includes: painting of equipment, piping and siding replacement; GE's & TESCO Controls commissioning activities; installation of canopy and ancillary room lighting; and equipment commissioning.

Barring any commissioning issues that may arise, the project is holding to schedule for production of effluent in early November. The District has also been in contact with HDR and the Department of Drinking Water for our future permitting of the new facility.
