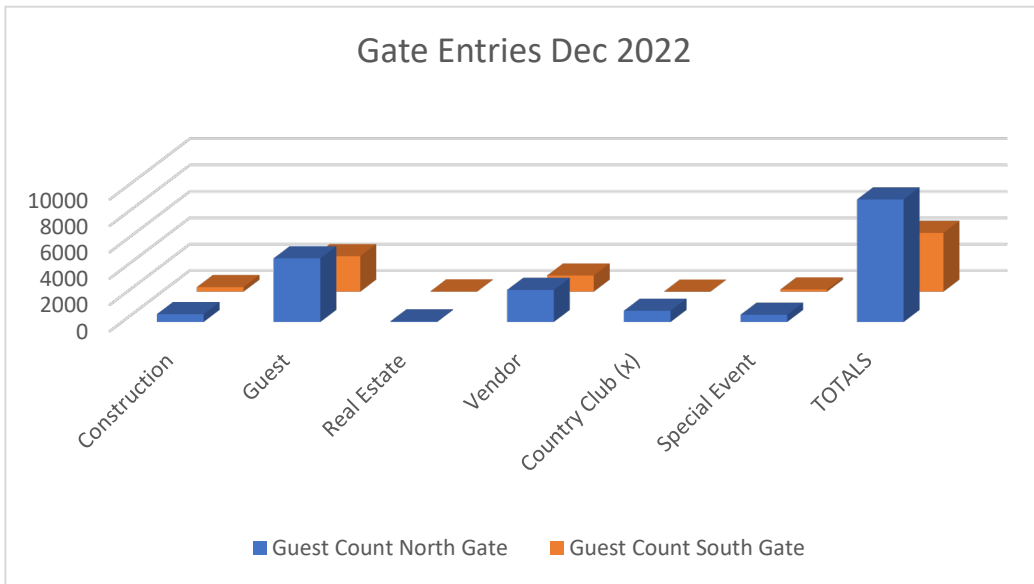

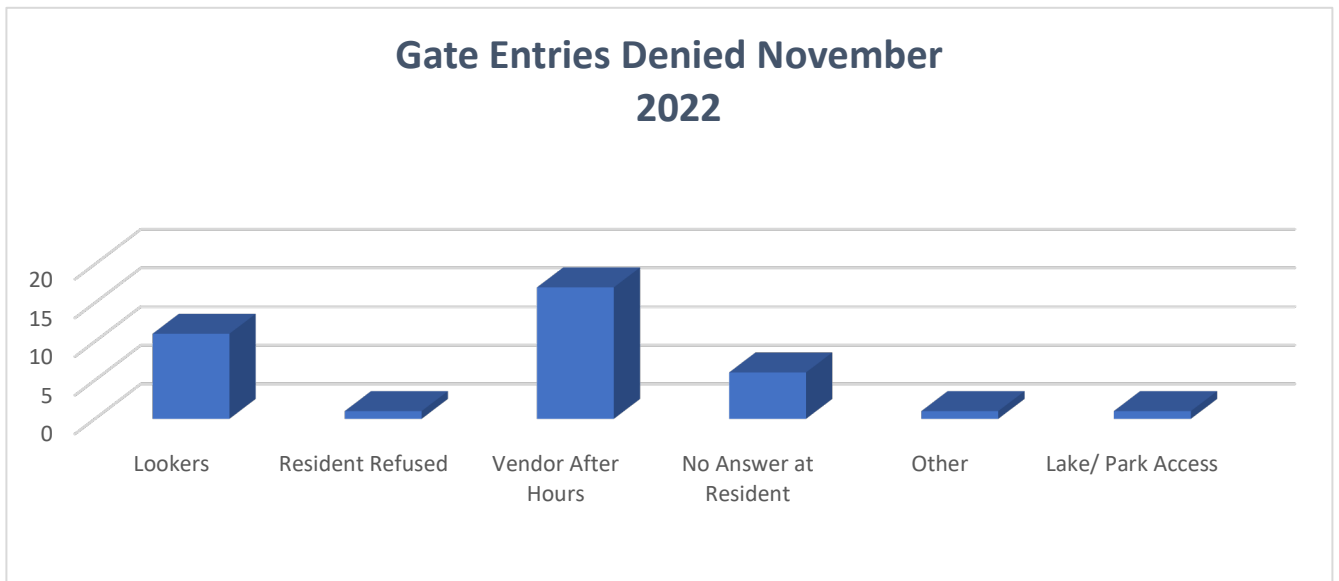

INCIDENTS OF NOTE
December 1-31st

On 12-15-2022 at approximately 1950 hours, CSD patrol was dispatched to the Murieta Village to investigate a mailbox theft. CSD Officer was advised the suspect entered the village with an unknown tool, forced open several mailboxes and removed several items, and fled with an accomplice in an unknown vehicle. The suspect was captured on the village's video camera and the incident was reported to the U.S. Postal service and the SSD. The suspect was described as a white male with glasses and was placed on our webpage and posted in the newspaper.

On Friday 12/30/2022 about 0730 hours, CSD observed part of the Cantova Way Storage fence falling towards the road. It appeared someone cut the straps on a thirty-foot section of fence, which made the top of the fence lean to the road. Murieta South storage manager was not able to pull any video surveillance to identify any suspects. Due to the recent burglary of the storage yard, extra patrol is requested and shall be granted as possible.
