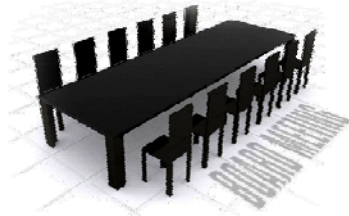

MANDATORY WATER CONSERVATION

Water Treatment Plant #1 will be shut down starting September 15, 2014 for the Water Treatment Plant Expansion Project. The District's water production will not meet all the water demands of its customers. Therefore, beginning September 1, 2014, there will be a mandatory maximum two (2) day schedule in effect. The North may water on Mondays and Fridays; the South, Murieta Village and Commercial may water on Tuesdays and Saturdays. Water times are from 12:00 a.m. to 10:00 a.m. only. Conservation will be enforced as follows:

Violation	Penalty
First	Personal or written notification of the violation
Second	Written notification and issuance of a notice to correct
Third	Issuance of an administrative penalty of \$100
Fourth	Issuance of a penalty of \$200
Fifth	Issuance of a penalty of \$500
Final	Disconnected water service and/or other penalties as provided in the notice of violation and as determined by the General Manager.

The District has a goal of 25% conservation. The less water we use now means the more we will have available next year. The fuller the reservoirs remain, the more we save on pumping costs.

REBATES

The District offers various rebates throughout the year. Here are the ones currently available.

- **Toilet Rebate:** You can receive a rebate of up to \$100 when you purchase and install a water efficient toilet.
- **Clothes Washer:** You can receive a rebate of up to \$125 when you purchase a high-efficiency clothes washer. The overall efficiency rating of the clothes washer will determine the amount of the rebate.
- **Weather Based Sprinkler Controller:** You can receive a rebate of up to \$100 when you purchase and install a weather based sprinkler controller.
- **Drip System:** You can receive a rebate of up to \$50 when you purchase and install a drip system.
- **Rotator Head Sprinklers:** You can receive a rebate of up to \$50 when you purchase and install rotator head sprinklers.

WASTEFUL USES OF WATER

- Water flowing away from a property caused by excessive application(s) of water.
- Hosing down hardscape such as sidewalks or driveways.
- Allowing water fixtures or heating or cooling devices to leak or discharge water.
- Maintaining or discharging from ponds, waterways, decorative basins or swimming pools without water recirculation devices or with known leaks, both seen and unseen.
- Continued operation of an irrigation system that applies water to an impervious surface or that is in disrepair.
- Use of a water hose not equipped with a control nozzle capable of completely shutting off the flow of water except when not in use.
- Irrigation of lawns or landscaping when it is raining.
- Irrigating lawns or landscaping outside the hours of 12:00 a.m. and 10:00 a.m.
- Using potable water from the District's water system for compaction, dust control, or other construction purposes without first obtaining approval from the General Manager and a meter from the District.

SCHOOL BUS REMINDER

When the **school bus stops** and the flashing **red** lights come on, vehicles must stop and wait behind the bus or facing the bus if the roadway is not divided. Bus drivers are very cautious in seeing that their riders are out of harm's way before moving on.
