



Subject: Discussion of Water Incident Communications Efforts

RECOMMENDED ACTION

Discussion item only.

BACKGROUND

On June 24, 2021, District staff responded to an alarm of low levels in the Water Treatment Plant tanks. Staff found a fire hydrant had been sheared off on an access road next to Lake Clementia. Staff sent out several Code Red alerts, alerting residents that the water would be off until approximately 11:30 am that morning. The following communications were provided to residents, as information was rapidly changing:

- Code Red Alerts via text messages, emails and phone calls
- Website updates, to include street lists and maps, boil water notification, etc.
- Facebook post
- Boil Water Notification fliers handed out
- Code Red information on June 25th utility bill message and inserts
- Security Information Bulletin insert for June 25th utility bill

SUMMARY

Administration staff completed a debrief to ensure that information is delivered to the residents in a timely and accurate manner and in the event that an emergency incident occurs in the future, staff will be prepared to provide up-to-date information quickly and accurately.
