

ORDINANCE NO. 88- 4

AN ORDINANCE OF THE RANCHO MURIETA COMMUNITY SERVICES DISTRICT, AMENDING CHAPTER 21 OF THE DISTRICT CODE, CONCERNING RATES FOR SECURITY SERVICE PROVIDED BY THE DISTRICT

BE IT ORDAINED, by the Board of Directors of the Rancho Murieta Community Services District, Rancho Murieta, Sacramento County, California, as follows:

SECTION ONE:

Section 5.02 of Chapter 21 of the District Code is amended as follows:

Section 5.02 The monthly charges for security service shall be as follows:

<u>Type of Unit</u>	<u>Charge per Unit or Acre</u>
(a) Constructed single family residence or townhouse lot	\$11.75
(b) Unconstructed residential or townhouse lot	10.50
(c) Mobile home lot	4.00

All other rates adopted by Ordinance 86-4 remain unchanged.

The charges listed for security service are "availability" charges only, which cover normal patrol and operations. Additional services may be provided by the Security Department as requested, at an hourly rate established by the Board.

SECTION TWO: To the extent the terms and provisions of this Ordinance may be inconsistent or in conflict with the terms and provisions of any prior District ordinance, resolution, rule or regulation, the terms of this Ordinance shall prevail with respect to the subject matter hereof and such inconsistent or conflicting terms and provisions of prior ordinances, resolutions, rules and regulations are hereby repealed.


SECTION THREE: The establishment, modification, structuring, restructuring and approval of the fees, rates and charges set forth in Section One hereof, are for the purpose of continuing to provide funds to meet the District's cost of operation and maintenance, supply and equipment, financial reserve, debt service and capital replacement needs, and are necessary to

maintain and improve service within the District's existing service boundaries.


SECTION FOUR: This Ordinance shall be published within 10 days of adoption in a newspaper of general circulation published within the District. Because of the District's fiscal year beginning on July 1, and the bi-monthly billing period starting on July 1, this ordinance shall take effect July 1, 1988.
