BACKGROUND / SITUATION

The Rancho Murieta Association and its community have held an annual Fourth of July event each year. There are a variety of events that take place during the day including a Kiwanis Club Pancake Breakfast, a Fun Run, a Vintage Car Parade, Music at the Gazebo, and the spectacular Fireworks show. However, in 2020, there was no event due to COVID 19.

RMA staff coordinates traffic control and access during the Fun Run, Parade, and the Fireworks event. It is imperative that crowd and access control to the Fireworks event be controlled due to State Fire Marshall regulations.

The District has provided assistance in the event each year to include access control to the community at the North and South Gates, traffic control, compliance reporting/violations, observe and report unlawful activities, and protect District properties. Contract security services are also utilized for this annual event to assist with traffic control and crowd control.

We have an excellent partnership with the Sacramento County Sheriff's Department, who provide off-duty hireback services for this event as well.

Historically, CSD Patrol Officers and SSD Deputies assigned to this event have responded to calls for service that include illegal fireworks, loud music/party calls, alcohol related disturbances, and traffic calls.

During this event, District will have additional uniformed CSD Patrol Officers and additional Gate Officers on duty from 0700 hours to 0100 hours. They will assist with access to the community, traffic control, and the protection of District properties. CSD Patrol Officers will also respond to calls for service within the District boundaries.

ABA Protection Inc. (the District's contract security provider) will be on duty from 1600 to 0100 hours. They will assist with traffic control, crowd control, and community information assistance.

Sacramento County Sheriff's Deputies will also be on duty from 1600 to 0100 hours. They will assist with calls for service, illegal fireworks suppression, and the protection of life and property.

CSD Gate Officers will provide access control into the community and will utilize the iPads at the gates to check in guests who have been issued RMA Fast Passes. Other visitors will NOT be permitted to enter the community without a Fast Pass or resident/guest permission.

Golf carts will be provided to all Security Officers throughout the day. They are available at the North gate.

LUNCH WILL BE PROVIDED AT 1200 HOURS AND 1800 HOURS TO ALL PERSONNEL.

The following events will occur during the RMA Fourth of July Event 2021:

Kiwani's Club Pancake Breakfast: 0700-0930 hours at Stonehouse Park <u>Objective:</u> Special checks only.

40th Annual 5K Fun Run: 0730 hours at North Gazebo <u>Objective:</u> Incident (including medical) response only.

Parade: 0745-0930 hours at Murieta Parkway and De La Cruz <u>Objective:</u> Traffic diversion and traffic control along North Murieta Parkway. RMA staff and CSD Patrol Officers will provide traffic control along the parade footprint. The Parade will begin at 2nd Domingo & De La Cruz, and end at the RMA building, with traffic moving southbound along RM Parkway. Regular traffic will be diverted to the Northbound lanes. Traffic cones, RMA staff and CSD staff will be present for the diversion.

Music at the Gazebo: 1900-2100 hours at the Gazebo at Laguna Joaquin <u>Objective:</u> Access control to the area by pedestrians who are residents and guests of residents. Other visitors will not be permitted. ABA Protection will be utilized for this area.

Fireworks Show: 2100 hours at Laguna Joaquin

<u>Objective:</u> Access and crowd control along RM Parkway at the Gazebo/Laguna Joaquin. There will be fencing along the sidewalk and A-frame signs to divert pedestrian traffic away from the launch site **per the State Fire Marshall**. ABA Protection and CSD Patrol Officers will be assigned to this area to guide people away from the area who are not residents or guests.

AFTER SHOW EXIT: The State Fire Marshall determines when the Fireworks show has officially ended, when it is safe. The exit route will be via the Escuela Gate and the North Gate.

MISSION / RESPONSE OBJECTIVES

I. MISSION:

The Mission for this event is the protection of property and life in the community, illegal fireworks suppression, and fire prevention.

CSD Patrol Officers and SSD will conduct high visibility enforcement, traffic and access control, and respond to calls for service in the community. ABA Protection Inc. will provide traffic control and access control in the community.

The objectives of this mission are as follows:

- Access Control into the community
- Traffic Control during the events throughout the day
- Compliance Reporting
- Protection of District properties
- Protection of life and property in the community
- 1. All CSD Patrol personnel assigned to the event will be in marked vehicles, will be in full department uniform, and carry all necessary safety equipment.
- 2. All CSD Gate Officers will be in full department uniform and will have necessary safety equipment available in the Gate houses.
- 3. All ABA Protection Inc. Security Officers will be in full company uniform with "Security" clearly visible, and will carry all necessary safety equipment.
- 4. All personnel assigned to this event will have their Police radio and communicate on channel TAC6. If there is an emergency situation, pursuit or foot pursuit, that radio traffic will remain on TAC6. The Sacramento County Sheriff's Department will be monitoring this radio channel.
- 5. Golf carts are available for Security personnel to use throughout the day/evening of the event (CSD Security and ABA Protection Inc.)

A. Enforcement Policies

- 1. Enforcement action against criminal activity will be taken immediately by the Sacramento County Sheriff's Department.
- 2. In cases of non-violent offenses, violations may be issued to residents for non-arch rules and CC&Rs.
- 3. In cases of criminal offenses, arrests shall be made by the Sacramento County Sheriff's Department. CSD Patrol Officers and ABA Protection Inc. Security Officers are limited to Citizen's Arrests in extreme cases, using established procedures per department policies.
- 4. All CSD Patrol Officers assigned to this mission will wear body worn cameras and adhere to department policy.
