#### **Repair of Raw Water Pipe from Granlees to Calero**

On June 20, 2024, it was reported to the District that there was a potential leak in the Clementia spillway. After an investigation, it was believed that the raw water line that takes raw water from the Cosumnes River to Calero reservoir was broken. Since we were not pumping anymore, Staff closed the valve at Calero reservoir to stop the leak.

The Board of Directors approved Resolution R2024-09 on July 17, 2024 authorizing the Emergency Repairs of the Granlees raw waterline leak using TNT Industrial Contractors. Inc to perform the repairs. On Monday July 29, 2024, TNT started the repair on the raw water line. The raw water line was exposed, and the break was found a few days later. We were not able to use the same type of pipe to do the repair due to the one (1) year lead time to get a new stick of pipe in the same material. After the pipe was exposed and examined further, it was determined that a patch being welded on the break would not work because of the thickness of the pipe.

It was determined that a 10-foot section of the pipe will be removed and replaced with a new ductile iron pipe. Since the old pipe is 33" and the new pipe will be 36", it was decided that new flanges would be fabricated to be able to adapt the two pipes together. TNT removed the section of pipe that is broken and fabricated the section of pipe that will be inserted for the repair. TNT is in the process of finishing the repair. Below are pictures of the section of pipe that has been removed.

# TREES AT THE ADMINISTRATION BUILDING

There have been some questions lately about the PVC pipes sticking out of the ground in front of the CSD Admin Building. In May of 2022, the Sacramento Tree Foundation planted 145 seedlings in front and to the side of our District Office. These trees

are native species, including Valley Oak, Interior Live Oak, Blue Oak, Black Walnut, Boxelder and California Buckeye. When the seedlings were planted, each tree was shrouded by a pipe to ensure that they would not be eaten by wildlife, namely deer, for the first three years. The agreement with Sacramento Tree Foundation also guaranteed that we would have living trees at the end of the three year agreement. We are happy to report that most of the trees are alive and well, and many can be seen bursting from the top of the pipe. The plastic pipes will be removed at the end of the three years (this spring). Some of the trees have not made it. The Tree Foundation replanted trees last fall, and will replant any dead trees in the next few weeks. We understand that the pipes may have been unsightly, but the will give these trees the opportunity to thrive and become beautiful, mature trees.



# **PROPER DISPOSAL OF AUTUMN ITEMS**
