RECOMMENDED ACTION

BACKGROUND

As part of the recent security information update request sent to residents, the District asked residents and tenants to include email addresses in their response. The provided email addresses have been entered into the Security information database. The District will work with ABDI, the vendor of the Security database system, to extract the email addresses in a format that can be uploaded to the program, Mailchimp, which is used by our website host. District General Counsel agrees with staff that we can use these collected email addresses for sending out District news and information provided that the ability to opt-out of the service is provided.

The regular communications and/or notifications sent by email would include items that occur on a regular basis such as the monthly Pipeline, notification that the Board Committee agenda and packet are available on the District website, notification that the Board meeting agenda and packet are available on the District website, etc.

Ad Hoc push communications would include items that occur on a single, high-priority basis such as notifications of drought stages, implementation of new rates, notification of emergency water line repairs, etc.
