

ORDINANCE 88-2

AN ORDINANCE OF THE RANCHO MURIETA COMMUNITY SERVICES DISTRICT, AMENDING CHAPTER 21 TO THE DISTRICT CODE, CONCERNING SECURITY SERVICE PROVIDED BY THE DISTRICT

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE RANCHO MURIETA COMMUNITY SERVICES DISTRICT, Rancho Murieta, Sacramento County, California, as follows:

SECTION ONE:

Section 7.00 of Chapter 21 is amended as follows:

(a) Vehicle Code: On all streets within the District, all the provisions of the Vehicle Code of the State of California, as amended from time to time, shall be applicable and enforceable by the District as rules and regulations under the covenants, conditions and restrictions affecting the tracts within the District boundary and pursuant to the authorized powers of the District. The provisions of the vehicle codes pertaining to the equipment of golf carts shall not be applicable in and enforceable by the District until August 1, 1988.

(b) Vehicles in Bicycle Lane: No person shall drive a vehicle (excluding golf carts) on or across a bicycle lane, except to: make a right turn at an intersecting street; enter a driveway; pick up or discharge passengers; park such vehicle; leave a parking space when provided adjacent to the bicycle lane; or obtain emergency parking. Emergency parking shall be allowed in bicycle lanes for disabled vehicles and emergency vehicles only. No person shall drive a vehicle upon or across a bicycle lane as permitted by this section except after giving the right of way to all bicycles in the lane.

(c) Skateboards - Prudent Operation:

(1) No person shall ride or propel a skateboard upon a private street, public roadway, or highway at a speed greater than, or in a manner other than, is reasonable or prudent, having due regard for weather, visibility, traffic, and the grade, surface and width; in no event shall the operation of the skateboard be at a speed or in a manner which endangers his or her safety or that of other persons or property.

(2) No person riding or propelling a skateboard shall attach the same or himself to any vehicle, animal, or bicycle.

(3) No person shall ride or propel a skateboard on or across any roadway in such a manner as to interfere with the movement of vehicles thereon.

(4) No person shall ride or propel a skateboard in the streets, sidewalks, or public parking areas of any business within the District.

(5) No person shall ride or propel a skateboard on a private street, public roadway, or highway during the hours of darkness.

Subsection (a) of Section 7.11 is amended as follows:

Section 7.11

(a) Dive or jump from any bridge, including, but not limited to, the Yellow Bridge or No.16 State Highway Bridge, into public waters:

SECTION TWO:

The Board of Directors hereby finds that it is feasible, economically sound and in the public interest for the Board to adopt the provisions of this Chapter as rules and regulations governing activities and use of streets within the District, in accordance with Government Code Section 61601.13 and the covenants, conditions and restrictions for the tracts within the boundaries of the District, and for any other tracts as may be annexed from time to time.

SECTION THREE:

To the extent and terms the provisions of this Ordinance may be inconsistent or in conflict with the terms and provisions of any prior District ordinances, resolutions, rules, or regulations, the terms of this ordinance shall prevail and such inconsistent or conflicting terms and provisions of prior ordinances, resolutions, rules and regulations are hereby repealed.

SECTION FOUR:

If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, no other provision of this ordinance shall be affected thereby.

SECTION FIVE:

This Ordinance shall be in full force and effect thirty (30) days after adoption and shall be published not less than once in a newspaper of general circulation published in the District within ten days after adoption.
