AN ORDINANCE OF THE RANCHO MURIETA COMMUNITY SERVICES DISTRICT AMENDING CHAPTER 15 OF THE DISTRICT CODE RELATING TO SEWER SERVICE

BE IT ORDAINED by the Board of Directors of the Rancho Murieta Community Services District, Rancho Murieta, Sacramento County, California, as follows:

SECTION ONE:

Section 8.08 of the Sewer Code, Chapter 15, of the District Code, is amended as follows:

SECTION 8:08: Fees - Building Sewer Connection Charge

- (a) Capital Connection Charges by Type of Facility.
- 1. Residential (No Change).
- 2. For multipule dwelling, Murieta Village residential lot, commercial, industrial, the Capital Connection Fee shall be .75 times the number of dwelling units times the fee for a 5/8" x 3/4" metered service.

SECTION 8.10 Sewage Use Charges - Exhibit A

Sewer services charges for each residential premise, except Murieta Village, for each unit \$14.00 monthly or \$28.00 bi-monthly, (no change).
