ORDINANCE 94-03

AN ORDINANCE OF THE RANCHO MURIETA COMMUNITY SERVICES DISTRICT
AMENDING CHAPTER 21 OF THE DISTRICT CODE
CONCERNING SECURITY SERVICE PROVIDED BY THE DISTRICT

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE RANCHO MURIETA COMMUNITY SERVICES DISTRICT, Rancho Murieta, Sacramento County, California, as follows:

SECTION ONE:

Section 7.13 of Chapter 21 of the District Code is hereby added, as follows:

7.13 District Officers working under 836.5 P.C shall enforce Section 25662(a) of the Business and Profession Code Minor in Possession of Alcohol.

Minor in Possession of Alcohol. Any person under the age of 21 years who has any alcoholic beverage in his/her possession on any street or highway or in any public place or any place open to the public or any common area, recreation area, or any place deemed open space within District of Rancho Murieta is quilty misdemeanor. This section does not apply to possession by any person under 21 years of age making a delivery of an alcoholic beverage in pursuance of the order of his/ her parent, responsible adult, relative, or any other adult designated by the parent or legal guardian, or in pursuance of his/her employment. That person shall have a complete defense if he/she was following, in a timely manner, the reasonable instructions of his/her parent or his/her legal guardian, responsible adult relative, or adult designee relating to the disposition of the alcoholic beverage.

Section 7.14 of Chapter 21 of the District Code is hereby added, as follows:

7.14 District Officers working under 836.5 P.C. shall enforce Section 25658 (a), (b), and (c) <u>Sale and Consumption of Alcohol by Minors</u>.

Sale and Consumption of Alcohol by Minors.

(a) Every person who sells, furnishes, gives, or causes to be sold, furnished, or given away, any alcoholic beverage to any person under the age of 21 years is guilty of a misdemeanor.

- (b) Any person under the age of 21 years who purchases any alcoholic beverage, or any person under the age of 21 years who consumes any alcohol in any on-sale premises, is guilty of a misdemeanor.
- (c) Any on-sale licensee who knowingly permits a person under the age of 21 years to consume any alcoholic beverage in any on-sale premises, whether or not the licenses has knowledge that the person is under the age of 21 years, is guilty of a misdemeanor.

SECTION TWO:

To the extent and terms the provisions of this ordinance may be inconsistent or in conflict with the terms and provisions of any prior District ordinances, resolutions, rules, or regulations, the terms of this ordinance shall prevail and such inconsistent or conflicting terms and provisions or prior ordinances, resolutions, rules and regulations are hereby repealed.

SECTION THREE:

If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, no other provision of this ordinance shall be affected thereby.

SECTION FOUR:

This ordinance shall be in full force and effect thirty (30) days after adoption and shall be published not less than one time in a newspaper of general circulation published in the District within ten days after adoption.
