MEASURE R – SECURITY BALLOT MEASURE – NOV. 8, 2022

Why is RMCSD proposing a new parcel tax measure for Security? When Measure J was approved in 1998 (24 years ago) it was based on rates that were adequate to provide 24/7/365 security with a 2% annual increase cap for Gates, Patrol, Assistance to other Agencies and registering guests. It was virtually impossible to predict the increase in costs to operate a Security department 24 years later.

- Over the past ten years the department has struggled to keep up with these costs.
- Over the past 6 years, RMCSD has been supplementing Measure J funds with our general purpose property taxes. In the near future costs will outweigh these funds also.
- This year it was determined by the Board of Directors that our reserves were dangerously low. Our aging infrastructure is having problems and needs repairs and replacements on a weekly basis. Along with other increases in costs across the board it was necessary to find a way to build up our reserves quickly.
- In the 2022/23 budget presented in March there were increases in water and sewer to capture some additional funding to build reserves. There were also increases in solid waste (new organics program) and Drainage and Security up to their 2% cap.
- These increases were disputed by a group of residents through protest letters and forms and the proposed budget was overturned.
- In the future, the Board of Directors has determined property taxes will not be used to supplement Security. The Board is proposing a new Special Tax, Measure R to make up the shortfall.
- After a year of polls, surveys and meetings community members let the Board know that security was extremely important to them and several options were presented.
- Option 2 was selected by the Board to put on the Ballot in November. Option 2:
 - * Will maintain security services at current levels 24/7/365.
 - * Will cost each household \$26.00 a month more.
 - * Will allow the District to free up property tax monies for reserves.
 - * Reserves need to be used to repair and replace critical infrastructure and for Water, Sewer & Drainage operations.
 - * Measure R funds would stay in Rancho Murieta for Security Services only.
 - * By Law, no funds can be used for other District operations or be taken away by the County or State or be used for other purposes.

DEVELOPMENT UPDATE

Riverview Developer has completed the block wall and headwalls for the 36-inch and 24-inch outlets for the crossing at Bird Loop. Framing has continued for the model homes on Mamba Court. The District has provided comments for the Phase 1A Record Drawings.

<u>Retreats</u> All water and sewer mains have been installed. The Developer is pre-testing the pressure on the water mains. The dry utilities are being installed. At the last board meeting the word "mothball" was used to explain the separation of the East from the North Retreats development. Mothball was a somewhat inaccurate way to describe what will be happening with the North portion of the project. KHov's engineer has been asked to separate North from East and finalize the East's Final Map so that the homes that are sold can close escrow. The final map creates the parcel that will become the homesites/lots within the subdivision. The North has fallen behind in having the "Models and Sales Office" because of the blasting and rock removal that Teichert ran into on the lots surrounding the models (Lots 3 and 4). KHov feels that the "mothball" comment is being interpreted as if they are shutting down the construction progress on the North. They are going as quickly as the conditions have allowed them to get all of the lots, utilities and ultimately the paving in, before the winter.

<u>Circle K/Shell</u> Plumbing inspection has been completed by the County. The Developer plans to potentially have the new station open by Thanksgiving.

Murieta Gardens Lot 2 (Tractor Supply) The District attended the preconstruction meeting on August 8, 2022. Veerkamp will be the onsite contractor.

WATER EFFICIENTLY FOR HEALTHIER PLANTS

Irrigation water running into a gutter or evaporating in the heat of the day does not get into the root zone of your plants. Therefore, adjust irrigation timers to water after sundown and at short intervals to allow irrigated water to set in to your soil. Two to three short watering cycles are far more efficient that one long cycle. Also, it is best to use drip irrigation systems when possible to target irrigation vs spray which may drift away from the area you want to water. Drip system rebates may be found on our website here: https://www.ranchomurietacsd.com/rebates Runoff water and drifting spray water may also create other issues like unwanted weeds or pooling areas of water in drainage systems where mosquitos may breed. Also, periodically check your irrigation system to ensure there are no leaks and irrigation heads are directed where you want them.

COMMUNITY SERVICES DISTRICTS

1. What is a Special District?

• A special district is a local form of government that is created, funded and overseen by a community's residents.

Serving the Community

- CSD's are formed to provide services in an unincorporated area of a county.
- There are many types of special districts that can be established to fit specific needs of a community. Most Districts provide one or possibly two services while Rancho Murieta provides <u>five.</u>
- Special District services can include: airports, cemeteries, fire protection, harbors and ports, libraries, mosquito and pest abatement, sanitation, water, sewage and drainage. More than 32 services in all.
- There are 2000+ community service districts throughout California. They vary in size and may serve a community of thousands or only a few hundred.

2. Why was RMCSD was formed?

- In 1980 the RMA and MTI Associations were responsible for accessing water, sewer, drainage, solid waste removal and security for the community.
- The El Dorado Irrigation District (EID) in Placerville was providing the water and sewer services. There were costs and issues that led to discussions and the consideration of a Community Service District for Rancho Murieta.
- Sacramento County Local Agency Formation Commission (LAFCO) was contacted and the process for forming a CSD was completed.
- In 1982 Rancho Murieta Community Services District was formed and began providing water, sewer, drainage and solid waste pickup.
- In 1984 the developer (PTF through RMPI) refused to continue paying for Security Services. The District took over the responsibility. *RMCSD is unique in being the only District in the State of California to provide in-house 24/7/365 security.*

3. What is Measure J?

- As a result of Prop 218 (a California Constitutional Amendment) the District was required to change the way it received revenue from its customers for Drainage (Measure K) and Security (Measure J).
- Funding is required through special parcel taxes. This funding was approved in 1998 by a 2/3rd majority vote of the community.
- At the time Measure J provided funds for security services that included:
 - * 24 hour gate operation
 - * 24 hour mobile patrol
 - * Assistance to outside agencies
 - * Assisting and registering guests
 - * Fees were based on charges broken down by residential inside the gates and outside the gates. The fees are broken down further for non-residential, undeveloped property, metered and unmetered lots.
- There is a yearly cap of 2% on increases.

4. Why doesn't Measure J fund Security?

Measure J is not a mandate to provide Security services. It is a description of the services to be provided with the revenue anticipated at the time it was passed, and at that time it was anticipated that the revenue would be sufficient to operate a Security Department and provide that level of service. 24 years later, it is not enough to fund that 24/7 level of service. The money is just not enough, unless we supplement it.

FOOD WASTE SERVICES COMING IN 2023


The State of California has implemented its new organic waste recycling requirements, in accordance with the statewide mandate, Senate Bill 1383.

Residential organic waste recycling (food scraps and yard waste) is anticipated to begin at the beginning of 2023 for most Cal-Waste residential customers.

Currently, there are no changes to residential collection and how you should sort your waste at your place of residence. When your city, county, or special district begins the collection of food waste and yard waste in a comingled container, Cal-Waste will provide complete information regarding the details of the new program.
