PUBLIC WORKSHOP-WATER SUPPLY ASSESSMENT REVIEW

On January 11, 2016 at 6:00 p.m. in the District board room, the District will hold a public workshop to address questions on the Water Supply Assessment (WSA) report prepared by Maddaus Water Management. The WSA was prepared at the request of Sacramento County to assess the District's water supply reliability in serving the proposed Rancho Murieta North development over a 20 year period in normal year, single dry year and multiple dry year conditions.

WATER TREATMENT PLANT EXPANSION PROJECT UPDATE

The anticipated start of the Water Treatment Plant #1's 30 day operational test has been delayed until the first of the year due to extended time required to finalize the coordination of the SCADA system controls with the GE membrane system operations. The expectation is to have the Department of Drinking Water on site January 7, 2016 for inspection and authorization to proceed with operating the new plant for the 30 day test period.

DISPOSING OF MEDICATION

Do you have medications, prescription and/or non-prescription, which have expired or are no longer needed? Proper disposal of medications prevents accidental ingestion, decreases the risk of drug misuse, and protects the environment.

- Do not flush medications down the sink or toilet.
- Ask your pharmacist if he/she will take back unused medications.
- Crush or dissolve unused medication in water (including liquid medications) and mix with kitty litter, dirt, sawdust, coffee grounds, or other solid kitchen substance.
- Seal the mix in an unbreakable, leak-proof container or bag, wrap with shipping tape or newspaper and put in the garbage as close to pick-up time as possible.
- Remove and shred or black out any prescription labels with personal information.
