MANDATORY WATER CONSERVATION

The Rancho Murieta Community Services District (District) has established mandatory restrictions on water use to help manage the District's potable water supply and minimize the effects of the drought. These restrictions are consistent with the emergency drought regulations recently adopted by the State Water Resources Control board.



Water restrictions include:

- Limit of 2 days per week of outdoor irrigation;
- Watering times are from midnight to 10:00 a.m.
 - Rancho Murieta North - Mondays and Fridays;
 - Rancho Murieta South, Murieta Village and commercial - Tuesdays and Saturdays;
- Washing down sidewalks and driveways is prohibited;
- Hose nozzle shut-offs are required at all times;
- No watering during or for 48 hours following measurable precipitation;
- The use of potable water in a fountain or other decorative water feature, except where the water is part of a recirculating system, is prohibited.

Violations and Penalties

- First Violation - Personal or written notification of violation.
- Second Violation - Written notification/issuance of notice to correct.
- Third Violation - Issuance of a penalty of \$100.
- Fourth Violation - Issuance of a penalty of \$200.
- Fifth Violation - Issuance of a penalty of \$500.
- Final Violation - Disconnect water service and/or other penalties as provided in the notice of violation and as determined by the General Manager.

WATER TREATMENT PLANT EXPANSION PROJECT UPDATE

Work on the Water Treatment Plant Expansion Project will continue through October 2015. During project construction, there may be increased traffic due to construction activity and deliveries.



Temporary water treatment capability will be used to meet the summer months' higher water demand while plant construction continues.

It is anticipated that usable treated water will be produced by the new plant in mid-September.

WEST NILE VIRUS

West Nile virus, which can cause fever and severe neurological disease, is transmitted to humans and animals through the bite of an infected mosquito. You can reduce mosquitoes around your home by reducing mosquito breeding sources – from bird baths and saucers to empty wheelbarrows and toys. These items can hold water for more than five to seven days. Be diligent and prevent mosquitoes from breeding! Dump any standing water that may produce mosquitoes.
