SPECIAL BOARD MEETING - AUGUST 21, 2015

The District will be holding a Special Board meeting on Friday, August 21, 2015 at 6:00 p.m. to a hear a presentation from Rancho Murieta Properties representative, John Sullivan, on their proposed development plans for the remaining undeveloped properties in Rancho Murieta North. The Board will not take any action at this meeting. **The public is welcome to attend.**

MANDATORY WATER CONSERVATION

The Rancho Murieta Community Services District (District) has established mandatory restrictions on water use to help manage the District's potable water supply and minimize the effects of the drought. These restrictions are consistent with the emergency drought regulations recently adopted by the State Water Resources Control board.

Water restrictions include:

- Limit of 2 days per week of outdoor irrigation;
- Watering times are from midnight to 10:00 a.m.
 - o Rancho Murieta North Mondays and Fridays;
 - Rancho Murieta South, Murieta Village and commercial -Tuesdays and Saturdays;
- Washing down sidewalks and driveways is prohibited;
- Hose nozzle shut-offs are required at all times;
- No watering during or for 48 hours following measurable precipitation;
- The use of potable water in a fountain or other decorative water feature, except where the water is part of a recirculating system, is prohibited.

SECURITY REMINDERS

CALIFORNIA WASTE RECOVERY SYSTEMS

California Waste Recovery Systems (CWRS) has been providing solid waste collection and disposal services to Rancho Murieta since November of 2005 and has always provided excellent service to the residents.



Services provided by CWRS, include:

- Household battery collection in recycling carts
- Cell phone collection in recycling carts
- Used cooking oil collection at the curb

Cal-Waste offers large item collection, up to four times a year per residence with 6 cubic yards (5'x4'x8') per pickup. Large items can include discarded household items such as: furniture, carpets, mattresses, clothing, large green waste, white goods and brown goods. Universal Waste Collection and Electronic Waste collection are also picked up with the large item collection service. Call Cal-Waste at 354-4154 to schedule your pick up.

Another service available is extra green waste collection December 1 through March 30. Yard waste is not limited to the amount in your yard cart — extra plastic bags will be collected curbside. Christmas trees are also collected each year.

Collection days are Tuesday, Wednesday, and Thursday, depending on your street address. The mid-week collection days avoids having containers left out by residents traveling over the weekend. Green waste and recycles are collected on alternate weeks. Garbage is picked up weekly. Hours of collection are no earlier than 7:00 a.m. and no later than 5:00 p.m., unless otherwise noticed.
