### **CONSERVING WATER**

Why use water efficiently?

This year's near-average snowpack evaporated or soaked into the soil rather than flowing into neighboring rivers and reservoirs. Dry conditions throughout California have continued to deteriorate.

While the Rancho Murieta region is in a strong position to meet the water supply needs of people, the dry conditions are looking increasingly dire for the environment.

We're asking everyone to use water efficiently at home to preserve our rivers for fish and wildlife.

#### Most water use occurs outdoors:

In the Sacramento region, most of the water we use daily goes on lawns and outdoor landscaping, and about 30 percent of that is lost due to overwatering and evaporation.

There are lots of ways to save water at home, but using water efficiently outdoors can make the biggest difference of all.

### Check before you water

Check soil moisture before turning on sprinklers—saves 80 gallons of water per day.

The best and most accurate way to know if your yard needs water is to check the soil's moisture level. Here are some ways to check:

- **Use a moisture meter.** This is the most effective way to tell if you need to water your yard. Moisture meters feature an easy-to-read dial that indicates if the soil is dry, moist or wet.
- **Do the screwdriver test.** Stick an eight-inch screwdriver into the soil. If you can push it in more than three inches below the surface, you don't need to water.
- **Dig down six to eight inches** with a small shovel or trowel and grab a handful of soil. Roll the soil around in the palm of your hand. If the soil easily forms a ball in your hand, you don't need to water.

#### **Replace Sprinklers:**

- Replace older sprinklers with more efficient rotary nozzles—saves 8 gallons of water per 1,000 square feet of yard per day.
- Upgrade to a WaterSense-labeled weather-based sprinkler timer—saves 100 to 150 gallons of water per day. Learn more about "smart" sprinkler timers at <a href="https://www.epa.gov/watersense/irrigation-controllers">https://www.epa.gov/watersense/irrigation-controllers</a>
- Add two to three inches of organic mulch around trees and plants to reduce evaporation—saves up to 30 gallons of water per 1,000 square feet each time you water.
- Adjust sprinklers to prevent overspray—saves 40 gallons of water each time you water.
- Water plants early in the morning to reduce evaporation—saves 50 gallons of water each time you water.

#### **Inside your home**

• Check and fix leaks—saves 30-50 gallons of water per day.


The most common type of leak inside a home is a toilet leak, which can waste 200 gallons of water per day. That's enough to wash seven loads of laundry every day for a month. Finding out if a toilet has a leak is simple and quick.

- Add a few drops of food coloring or a dye tab to the tank and wait about 15 minutes.
- If the color appears in the bowl, there is a leak.
- The cause of a toilet leak is often a worn toilet flapper, which can break down over time.
- And, when in doubt, be sure to consult a professional plumber.

# GENERAL MANAGER'S CORNER BUDGET REVENUE UPDATE

For the Fiscal Year 2021-22, the District's Proposed Budget, including Prop 218 rate increase notifications, was released to the public at a Special Board meeting on April 1, 2021. On that date, the total proposed budget was \$7,998,988, which is an increase of \$776,461, or 11% over the previous year. This proposed increase resulted in 143 protest letters, some of which included questions. We addressed these questions by producing a frequently asked questions (FAQs) document posted on our web page.



After a thorough evaluation of the District's ability to maintain service levels, manage capital projects (which is the Board's number one goal), and provide superior service to ratepayers, we presented an update at our May 19, 2021 Board meeting. This update included a recommendation to reduce the budget by \$180,000 by eliminating a proposed position to support our recycled water program and construction inspections. This change reduces the monthly increase to all rate payors by six dollars. Our proposed balanced budget includes rate increases to water, sewer, and sewer reserve contributions and a 30% increase in Solid Waste's contract with Waste Management services. The budget also includes 2% increases for Drainage and Security charges as allowed through Measures J and K, passed by Rancho Murieta voters in 1998.

We are holding two additional budget-related meetings before the final approval on June 16. The first will be to update and answer questions at the Finance Committee on June 2<sup>nd</sup>. The second will be a Special Board meeting on June 4<sup>th</sup>. We will evaluate our reserve requirements and review the District's capital improvement/replacement strategy at this meeting. We are holding this to allow the Board to take a position on District Reserves.

### Employee Spotlight – Utility Worker II —Mario Moreno

**Mario Moreno** started with the District as a Utility Worker I in April of 2014. Mario was an amateur boxer for 11 years, prior to joining the District. Now he spends his days at the District, repairing water leaks, maintaining water and sewer lines, and working on special projects, like replacing fire hydrants. While working at the District, the most exciting thing that happened was when he saw a couple in a golf cart, and the wife was calling for help. Her husband was not breathing, so with help from his coworker they put him on the ground, and Mario performed CPR for 7 minutes, until the fire department arrived, thereby saving the man's life. His favorite thing to do when he's not at work is go fishing in his boat!

MG- Lot 10 (PDF Office)—Civil plans have been approved and are waiting for signatures.

We have had huge success with the electronic FastPass program at the North Gate. Thank you to the residents that used this system.

We want to remind everyone that the FastPass system is a full-time system and is able to be used all year. Please use it. The check-in process for your guests takes a couple of seconds versus 30-45 seconds the regular way. We encourage all residents to use this new system all the time for their guests, and especially during major holidays when Rancho Murieta experiences more gate traffic than normal.

A reminder though, this system is only at the North Gate for Northside residents. It is not available on the South at this time. Please sign up for an account on <a href="https://www.gateaccess.net">www.gateaccess.net</a>, either the desktop or mobile version. From there you will be able to send your guests the FastPass.

We have set up additional lanes to check in Guests that are visiting the community for special events and will keep the website and Facebook page updated when we are expecting a extra traffic.
